

## Press Release 51 - Joint Council for Cosmetic Practitioners (JCCP) Confirms the Appointment of Key Opinion Leaders

The JCCP was established in April 2018 as a UK national Charity. The Joint Council for Cosmetic Practitioners (JCCP) and the Cosmetic Practice Standards Authority (CPSA) are recognised self-regulators of the non-surgical aesthetic and hair restoration surgery sector in the United Kingdom and the point of access for the public seeking information about this area of practice and where appropriate for raising concerns about practitioners. The JCCP places public protection and patient safety as the focus of its activities. The Council operates a Professional Standards Authority Practitioner Register and a register of approved qualifications and training providers that operate in the aesthetic sector.

As part of its 'Marketing and Communications Plan' the JCCP has established the role of 'Key Opinion Leader' (KOL). This role has been designed to enable some of the most influential people in the non-surgical and hair restoration surgery specialisms to sign up to the core values of the JCCP and where appropriate to reflect these values in statements, presentations and other interactions with the aesthetic world and media. Key Opinion Leaders are free to determine how and when they wish to support the JCCP. From time to time the JCCP requests support from KOLs for a particular action, campaign, or proposal.

Key Opinion Leaders may elect to represent the JCCP and the CPSA occasionally at key national conferences, events, presentations, and seminars and to offer views on JCCP activities, policies, or actions on social media.
