The Joint Council for Cosmetic Practitioners (JCCP) and the Medicines and Healthcare products Regulatory Agency (MHRA) sign a Memorandum of Understanding (MoU)

Advisory notice: The JCCP and the MHRA have signed a memorandum of understanding to improve collaboration.

The JCCP and the MHRA have signed a memorandum of understanding to improve collaboration. Together we will improve public protection and consumer safety in the aesthetic industry through positive engagement between our two organisations; working towards the promotion of safer medical devices and medicines and examples of best and safe practice within the aesthetic industry.

The purpose of the Memorandum of Understanding is to set out a framework to support the working relationship between the Joint Council for Cosmetic Practitioners the Medicines and Healthcare products Regulatory Agency (MHRA), an executive agency of the Department of Health and Social Care. Both parties have also agreed to work to promote safe practice through the forum of the JCCP's Clinical Advisory Group (CAG).

The MoU defines a joint agreement between the two parties and indicates a common line of action and seeks to promote a clear understanding of the operational expectations and governance arrangements required to ensure a mutually beneficial relationship.

In particular the parties will exchange lawful communication where:

• 'either JCCP or the Agency identifies concerns about the health and wellbeing of the public, particularly in relation to the use of medicines or medical devices in the non-surgical aesthetic industry and those concerns are considered to be relevant to the other organisation's regulatory functions; and;

• a resolution to a concern would benefit from a coordinated multi-agency response and provision of information to

Background:

The MHRA is an Executive Agency of the Department of Health and Social Care and was established on 1 April 2003. It is the UK regulator of medicines, medical devices and blood components for transfusion. Some of the Agency's priorities are:

- making our regulation more supportive of safe innovation
- supporting the government's growth agenda through the life science strategy

• introducing a combined reporting system for adverse incidents, medicines, medical devices, blood and counterfeit products under the established Yellow Card brand to ensure patient safety

• building effective international partnerships to strengthen regulatory systems to protect public health worldwide

• engaging and networking with healthcare professionals, patients and the public, including working jointly with others in the health and social care system

The Joint Council for Cosmetic Practitioners (JCCP) is a UK Charity (accredited by the Professional Standards Authority) and functions as a recognised self-regulator of the non-surgical aesthetic industry in the UK and as point of access for the public seeking information about this area of practice and where appropriate for raising concerns about practitioners. The JCCP places public protection and patient safety as the focus of its activities. The JCCP works seamlessly with the Cosmetic Practice Standards Authority (CPSA) and adopts and implements standards set by that organisation.
