

# The JCCP Practitioner Register for members of the public

The JCCP registers a wide range of practitioners from different backgrounds with varying levels of experience and training or qualifications. Many are healthcare professionals such as doctors, dentists, nurses, pharmacists and physiotherapists etc (Register Part A) and others come from a beauty therapy background (Register Part B). Members of the JCCP Register reflect the complexity of the aesthetic sector, but importantly, all our registrants agree to provide their services according to a code of JCCP approved standards.

By using the JCCP register to choose your practitioner, you are probably seeking assurance that they meet your specific requirements.

The JCCP believe that, in addition to standards of practice, you should have access to sufficient information to enable you to recognise the qualifications and/or the experience of your practitioner.

## PART A OF THE PRACTITIONER REGISTER IS DIVIDED BETWEEN CATEGORY 1 AND 2.

- Category 1 practitioners meet all JCCP requirements, including training standards.
- Category 2 practitioners are registered healthcare professionals who may not have achieved the JCCP training standards. They have yet to complete a JCCP approved qualification, but you can be confident that, as regulated healthcare professionals, they are obliged to work only within their sphere of competence. They should be working towards achieving a JCCP approved qualification.
- Healthcare professionals on Part A of our register have additional obligations set down by their professional regulators. Amongst much else, they have a duty of care towards your best interests and must only provide procedures that they are competent to perform. Part A of the Practitioner Register is divided between Category 1 and 2.
- Healthcare professionals usually have a high level of qualification (often a degree) in their field which forms the basis for their cosmetic work.



## **PART B OF THE PRACTITIONER REGISTER**

- Part B - full practitioners meet all JCCP requirements, including training standards, for the services they are authorised to perform by the JCCP.
- Registrants on Part B of the JCCP Register do not hold a registered healthcare qualification. This is why the JCCP only registers its Part B members to perform lower risk, non-injectable procedures.

## **THE JCCP ALSO INCLUDES A PROVISIONAL CATEGORY ON ITS REGISTER FOR LESS EXPERIENCED PRACTITIONERS.**

- Provisional registrants on both Parts A and B are usually relatively new to the cosmetic non-surgical sector. They have yet to obtain a qualification or significant experience. They should work within the limits of their competence and according to the standards defined by the JCCP. They may require supervision for some procedures and you may wish to check this with them.
