Organisational Profile

The Joint Council for Cosmetic Practitioners (JCCP) was formed in 2015 and officially launched in 2018 with the aim of ensuring the highest levels of safety for patients seeking non-surgical and hair restoration treatments.

The JCCP Board of Trustees consists of both clinical and lay members. The JCCP holds a voluntary register for practitioners in non-surgical and hair restoration treatments.

Our key work strands include:

- Maintaining and publishing a Professional Standards Authority accredited, publicly accessible register of practitioners who meet the JCCP/CPSA Standards.
- Promoting awareness of the Register among the public/patients, practitioners and education/training providers.
- Approving high standards of education and training and continuing professional development for the sector.
- Maintaining and publishing a publicly accessible register of Education and Training Providers, qualifications and programmes that meet JCCP standards and the JCCP Competency Framework.
- Investigating complaints and taking appropriate action via the JCCP Fitness to Practice procedures and the JCCP/CPSA Code of Practice.
- Engaging in political activity to champion public protection and patient safety and in particular campaigning for the introduction of statutory regulation for non-surgical and hair restoration practitioners.

The JCCP has outsourced the management of its register, general administration, IT, social media and finance functions.

The JCCP is accredited by the Professional Standards Authority (PSA) and achieved Charity Commission approval as a Registered Charity in 2018. The independent and professional status of the JCCP Charity is increasingly recognized by an impressive and growing number of stakeholders and key influencers throughout the UK. The PSA accreditation marks the JCCP's on-going commitment to provide the highest levels of governance, standard-setting, education and training, management of its registers, public protection, complaints handling and information provision.
