



# JCCP Self-Declaration Statement and Evidence Requirements.



The JCCP will only accept applications for registration where the applicant agrees to abide by its various conditions of practise. By completing this application, you confirm that you understand and self-declare that you:

- Practise lawfully.
- Practise safely and proficiently in accordance with the CPSA Practice Standards for your procedure/level of practice.
- Are of good character and declare any police convictions or cautions or any employment-related disciplinary matters that are current or pending at the time of your application.
- Agree that if you are a member of another PSA Accredited Voluntary Register or are registered by a Professional Statutory Health Care Regulator to advise the JCCP is you become the subject of investigation or sanction by that organisation/professional regulator. Furthermore, I agree that the JCCP may annotate my JCCP public facing registration record with details of any sanctions that may be imposed upon me by another PSA Accredited Voluntary Register or by a Professional Statutory Health Care Regulator.
- Practise in accordance with the JCCP and CPSA Supervision Matrix and its inherent requirements as specified therein.
- Practise within the requirements of the JCCP Prescribing Guidelines.
- Confirm that you operate from safe premises and self-declare against the checklist of premises standards.
- Declare that you will operate and practise only within your self-declared scope of practice with regard to the modality and level of practice that will be recorded as having achieved and which will be displayed on the JCCP Register.
- Will maintain an appropriate and proportionate level of insurance/indemnity and that you will inform JCCP of any material changes.
- Declare that you will abide by the JCCP/CPSA Code of Practice and use the same to guide, inform and improve their practice both ethically and professionally.
- Confirm that you possess the baseline experience, knowledge, skills, competencies and confidence to practise safely and proficiently within the procedural area/s of practice/level for which you are registered with the JCCP. Registrants must also be able to defend their practice in accordance with the standards set down by the JCCP as safe, knowledgeable/competent practitioners for each of the procedures that they perform in accordance with the detailed set knowledge and competence standards that are set out in the CPSA standards for each modality/level and by the JCCP in its Competence Framework for Cosmetic Practice (2018)'.- Confirm that you are up to date with regard to your continuing professional development post-initial training, and that you have engaged in continuing personal and professional development relevant to their cosmetic practice.
- Confirm that you understand that the JCCP will expect all Registrants to reflect on the JCCP/CPSA Code of Practice (2023) as part of their annual CPD.



You further understand and agree to the following:

As part of the JCCP's obligation to the Professional Standards Authority, you may be called upon at any time to provide additional evidence, approved by your supervisor or peer reviewer, to confirm that you meet the JCCP/CPSA standards for:

- CPD
- Premises
- Treatment numbers

If you are a Registered Health Care Practitioner and have not attained a JCCP approved qualification at the time you enter the JCCP Practitioner Register, you will be admitted to either Part A, Category Two of the full practitioner register or to the provisional register, depending upon your current practice experience. In this case you understand and agree that:

- You will self-assess your competence against the JCCP Competence Framework (2018) and you will either achieve a JCCP approved qualification, attend a JCCP approved centre for assessment of competence or otherwise demonstrate equivalence through JCCP approved routes to provide the requisite evidence that you meet all of the JCCP standards/competencies and requirements for full registration on Part One – Category One of the Council's Practitioner register. You will achieve this in a timeframe stipulated by statutory licensing legislation when it is introduced.

Your application to the JCCP and the part of the register to which you can apply is subject to your status or otherwise as a regulated healthcare professional and the competence and experience you can demonstrate. The JCCP will seek confirmatory evidence of your regulated status. As an applicant you agree to provide evidence of your training, qualifications, and experience on request.

### Adverse incident reporting

As part of your membership of JCCP you understand that you will be required to record and to provide yearly to JCCP anonymised data regarding adverse incidents for the purposes of statistical analysis. You also confirm your responsibility to report adverse incidents to the appropriate organisations, including to MHRA using the 'Yellow Card' scheme.

### Products

You agree to provide to customers only those products that have been legally, ethically and responsibly sourced from appropriate suppliers, including medicines and medical devices from UK approved distributors or their nominated registered pharmacies.



## Use of the PSA Accredited Register Quality Mark

I confirm that, as an approved registrant of the Joint Council for Cosmetic Practitioners Register (JCCP):

- I will use the PSA Accredited Registers Quality Mark only while my JCCP approval is current and valid.
- I will remove the Quality Mark immediately if my approval is revoked, expires, or if requested to do so by the JCCP.
